Description

1. The Davao del Sur State College, through the Fund 164 intends to apply the sum of Four Million Five Hundred Thousand Pesos (Php 4,500,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for DSSC PSU 2024-01-004. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Davao del Sur State College now invites bids for the "Supply & Delivery of One (1) Unit Minibus". Delivery of

the goods is required 60 calendar days upon receipt of the Notice to Proceed. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non- discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from Davao del Sur State College and inspect the Bidding Documents at the address given below from 08:00 A.M to 05:00 P.M (Monday to Friday) except holidays.

5. A complete set of Bidding Documents may be acquired by interested Bidders on March 04 to 27, 2024 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids in any of the following payments options:

- Over-the-counter payment at DSSC-Cashier’s office, Brgy. Matti, Digos City, Davao del Sur;
- Over-the-counter deposit at Land Bank of the Philippines (LBP) Account No. – 0332-1103-57.

Prior to payment, bidders are advised to coordinate first with the BAC Secretariat, through mobile phone at (+63) 951-822-5510 (Smart) for the issuance of the “Payment Order” and instructions.

6. The Davao del Sur State College will hold a Pre-Bid Conference on March 13, 2024 (01:00 P.M.) at Davao del Sur State College, Brgy. Matti, Digos City, Davao del Sur, which shall be open to all prospective bidders but limited to two (2) physically present representative per bidder only. The Pre-bid Conference is likewise accessible online via Zoom.

7. Bids must be delivered to the address below on or before March 27, 2024 (01:00 P.M.). All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.1.

Bid opening shall be on March 27, 2024 (02:00 P.M.) at Davao del Sur State College, Brgy. Matti, Digos City, Davao del Sur, which shall be accessible also online via Zoom.

Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Maximum of two (2) representatives of the Bidder shall be allowed to physically attend in the opening of bids. Late bids shall not be accepted.

8. The Davao del Sur State College reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
