**Description**

1. The Davao del Sur State College, through the Fund 164 2024 intends to apply the sum of Four Million Twenty Thousand Pesos only (Php 4,020,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for DSSC Coffee Research and Innovation Center Architectural and Interior Fit-out (Negotiated Procurement: Two-Failed-Biddings)/DSSCPSU 2024-07-11. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Davao del Sur State College now invites bids for the above Procurement Project. Completion of the Works is required within 150 calendar days from receipt of the Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from Davao del Sur State College and inspect the Bidding Documents at the address given below from 08:00 A.M to 05:00 P.M (Monday to Friday) except holidays.
5. A complete set of Bidding Documents may be acquired by interested bidders on July 10 to 31, 2024 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees either in person or through e-mail.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids in any of the following payments options:

- Over-the-counter payment at DSSC-Cashier's office, Brgy. Matti, Digos City, Davao del Sur;
- Over-the-counter deposit at Land Bank of the Philippines (LBP) Account No. – 0332-1103-57.

6. The Davao del Sur State College will hold a Pre-negotiation Conference on July 18, 2024; 01:00 P.M. at Davao del Sur State College, Brgy. Matti, Digos City, Davao del Sur and/or through videoconferencing/webcasting via Zoom, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before July 31, 2024; 01:00 P.M. Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.

9. Bid opening shall be on July 31, 2024; 01:00 P.M at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

10. The Davao del Sur State College reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
