**Description**

The Davao del Sur State College, through the Fund 163E 2024 intends to apply the sum being the Approved Budget for the Contract (ABC) to payments under the contract for each lot:

LOT 1 - SUPPLY, DELIVERY, AND INSTALLATION OF ENVIRONMENTAL SCIENCE EQUIPMENT  
Php 1,904,000.00

LOT 2 - SUPPLY, DELIVERY AND INSTALLATION OF GENERAL LABORATORY EQUIPMENT  
Php 2,378,000.00

LOT 3 - SUPPLY, DELIVERY, AND INSTALLATION OF FOOD PROCESSING LABORATORY EQUIPMENTS  
Php 463,000.00

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

The Davao del Sur State College now invites bids for the above Procurement Project. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to

Bidders).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

Prospective Bidders may obtain further information from Davao del Sur State College and inspect the Bidding Documents at the address given below from 08:00 A.M to 05:00 P.M (Monday to Friday) except holidays.

A complete set of Bidding Documents may be acquired by interested Bidders on July 19 to August 7, 2024 from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB. The Procuring Entity shall allow the bidder to present its proof of payment for the fees either in person or through e-mail.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPs) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids in any of the following payments options:

- Over-the-counter payment at DSSC-Cashier's office, Brgy. Matti, Digos City, Davao del Sur;
- Over-the-counter deposit at Land Bank of the Philippines (LBP) Account No. – 0332-1103-57.

The Davao del Sur State College will hold a Pre-Bid Conference on July 26, 2024; 01:00 P.M. at PSU Office, Davao del Sur State College, Brgy. Matti, Digos City, Davao del Sur and/or through video conferencing or webcasting via Zoom, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before August 7, 2024; 01:00 P.M. Late bids shall not be accepted.

All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

Bid opening shall be on August 7, 2024; 01:00 P.M at the given address below PSU Office, Davao del Sur State College, Brgy. Matti, Digos City, Davao del Sur and/or via Zoom. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Davao del Sur State College reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
